Fittings and tensioning wires in 316 marine grade stainless steel

Steel lugs to be welded to under side of I beams.

Total sq meterage of netting 187.87 sqm

¹ * MSCM Regulations: "in the service of the state" means to be –

- (a) a member of –
 - (i) any municipal council;
 - (ii) any provincial legislature; or
 - (iii) the national Assembly or the national Council of provinces;
- (b) a member of the board of directors of any municipal entity;
- (c) an official of any municipality or municipal entity;
- (d) an employee of any national or provincial department, national or provincial public entity or constitutional institution within the meaning of the Public Finance Management Act, 1999 (Act No.1 of 1999);
- (e) a member of the accounting authority of any national or provincial public entity; or
- (f) an employee of Parliament or a provincial legislature.

3. Applicants must indicate when the works will commence and the time required to complete the supply and installation.
4. The applicant's SMME status.
5. An original valid Tax Clearance Certificate.
6. The Declaration of Interest and the BEE Forms as found on the JDA website, must be scrutinized, completed and submitted together with your quotation.
