**REQUEST FOR PROPOSALS FOR A SERVICE PROVIDER TO UNDERTAKE AN ANALYSIS OF AREA-BASED REGENERATION STRATEGIES IN LOW-INCOME, HIGH-DENSITY INNER CITY NEIGHBOURHOODS**

The Johannesburg Development Agency (JDA) is a wholly owned agency of the City of Johannesburg which stimulates and supports area-based based development initiatives throughout the Johannesburg metropolitan area in support of the City of Johannesburg's Growth and Development Strategy.

As development manager of these initiatives, the JDA coordinates and manages capital investment and other programmes involving both public and private sector stakeholders.

Kindly furnish me with a written quotation for the supply of the professional services as stipulated below.

The JDA invites tenders from service providers with experience in undertaking research and analysis. The JDA is calling for a service provider to undertake a review and analysis of successful area-based regeneration strategies in high-density, low-income residential inner city neighbourhoods such as Harlem, USA.

The purpose of the analysis and review is to generate sufficient information on international best practice. This analysis and review study should provide information that will contribute towards conceptualising future plans for the regeneration, improvement and redevelopment of Inner City neighbourhoods in Johannesburg. The first part of the report should cover at least 5 relevant international case study areas. Each of these should be discussed separately. The second part of the report should analyse the similarities and differences in the approaches adopted in the case study areas and the reasons for their successes and commonalities. The third part of the report should provide a synthesised summary report of variables that could be applied in the context of the City of Johannesburg.

The scope of work for the review and analysis of the five case study areas will include at least the following:

- A socio-economic analysis of the case study areas
- An analysis of public investment in the areas
- An analysis of private sector investment in the areas
- An overview of catalytic projects in the areas that spearheaded area-based regeneration
- Mechanisms used/ developed by the public sector to support investment in these areas

This project will commence by end of March 2008 and the completion date is 30 May 2008.
