### **REQUEST FOR PROPOSALS FOR A SERVICE PROVIDER TO UNDERTAKE STUDY LOOKING AT THE REQUIREMENTS FOR INTERNATIONAL BUSES IN THE INNER CITY**

The Johannesburg Development Agency (JDA) is a wholly owned agency of the City of Johannesburg which stimulates and supports area-based based development initiatives throughout the Johannesburg metropolitan in support of the City of Johannesburg's Growth and Development Strategy.

The JDA in partnership with the City of Johannesburg's Transportation Department invites tenders from specialist consultants with experience in transportation-related issues to undertake a detailed analysis which will evaluate the Inner City's facilities requirements for accommodating international buses now and for 2010.

The purpose of this piece of work is to provide information that will guide the City in developing a viable and workable solution for accommodating international buses entering the City now and in the future.

The study will provide the following outcomes:

- Detailed information on the overall requirements for international buses in the Inner City, including for 2010.
- Detailed assessment of the number of international buses entering the Inner City daily. Work done by the JDA in 2007 suggested that 134 international buses entered the Inner City daily. Latest unconfirmed information anticipates that the number of international buses arriving daily during the 2010 World Cup is 440. Updated information is a requirement of this study.
- Detailed analysis on the viability of using Westgate Station to accommodate international buses in the present and the future for ranking and holding.
- Detailed analysis of the viability of using Faraday Taxi Rank or surrounds to accommodate international buses in the present and for 2010 for ranking and holding.
- Propose additional feasible sites within the Inner City that could be used to accommodate international buses for ranking and holding now and for 2010.

This project will commence by 7 November 2008 and the completion date is January 2009.

The quotation must be submitted on the letterhead of your business and can either be faxed or delivered by hand not later than 12.00 on 31 October 2008 to: The Bus Factory, 3 President Street, Newtown. Johannesburg. The quotation should also include a company profile and references for similar work undertaken.
